## **Expanded Social Adjustment Services in Alameda County:**

Social Adjustment (SA) Workers: Social Adjustment is a term used by the Federal Office of Refugee Resettlement for services intended to assist new arrivals who have been in the U.S. for the time period of 0-5 years' time and are in need of extra scaffolding to learn how to navigate through new western systems and build life skills essential to functioning well in the different realms of life. SA workers are permitted to provide translation, interpretation, and escort and advocacy for clients attending appointments where're navigational or language barriers are anticipated.

- There are currently three different, small contracts in Alameda County for SA services, two of which pair social adjustment with employment programs.
- Workers were chosen by the contracted agencies to help ensure services according to
  greatest numerical country of origin arrival numbers as well as greatest navigational
  difficulties faced by new arrivals (such as a large percentage of households headed by
  pre-literate persons).
- The contracted agencies include Burma Refugee Family Network, Refugee Transitions, and Catholic Charities of the East Bay. RT and BRFN have created a consortium of service providers under central program management for this new model. The new model will hold monthly care coordination meetings regarding all clients served in the program to help ensure that basic service needs are met and clients are then less likely to fall through the cracks. The consortium is dedicated to making out- referrals to specialty services needed to include those in legal, mental health, and crisis categories.
- The forum coordinator will act as trainer of the new SA workers so that they have basic case management skills as well as understanding of safety net services throughout the county. Coordinator will also support workers to make cross-systems connections to resolve client issues or obtain needed services. Some trainings will also be available to the broader pool of forum member agency staff or community advocates who wish to attend. Such meetings will be offered by pre-announcement through the list serve.

- Agencies are asked to use the referral form for clients in need of services. All referrals must go through the Program Manager, Harnit Kang, who will funnel them forward to SA workers according to criteria such as language match and grant requirements (each grant serves a slightly different category of new arrival such as CalWORKS recipients are served under one grant, and RCA under another. It is the goal of the consortium that the client should receive services without concern as to which grant the funding comes from. Services will be co-located, for the most part, at a new site. OUSD RASAP program has one part time SA worker hired under one grant to help Unaccompanied Minors from Central America who have been granted asylum help access public benefits and essentials such as Social Security number application and CA id application.

Medi-Cal expansion to Undocumented immigrant children under the age of 19 years was passed in Senate Bill 75 on May 16<sup>th</sup> 2015. CA is currently the only state to offer such coverage to this population.

• It provides full coverage for children under the age of 19 regardless of their immigrant status. Individuals must meet eligibility criteria regarding income. - In that website you will find the following information to avoid a gap in service:
- Medi-Cal has been discontinued and I am now able to enroll in Covered California during a Special Enrollment Period (SEP), how can I avoid a gap in my health coverage?
- If your Medi-Cal will be or has been discontinued, in order to avoid a gap in your health coverage, you should pick a Covered California plan before the date your Medi-Cal ends. If you do not select a Covered California plan in the same month your Medi-Cal ends, you will not have health care coverage for at least a month. You must also pay your Covered California premium by the due date when you are billed in order to be covered. If your request for enrollment is completed within 60 days of the qualifying life event date, the soonest your Covered California health plan can start will be the 1st of the month following your Covered California plan.selection. If you wait more than 60 days after your Medi-Cal ends to pick a Covered California plan, you may not be able to enroll until Covered California's next Open Enrollment Period. You may contact Covered California online at CoveredCA.com or call 800-300-1506 or contact your County Eligibility Worker for assistance in selecting your Covered California plan. Of 100 individuals 42 are children, which is 42% of the caseload 100.

23 of 42 children are school age (54%), 19 are under 5 years old.

Males-52; Females- 48.

78 individuals (78%) of 100 arrived refugees are Afghans; 7 Iraqis; 2 Columbians, 5 Syrian, and 4 Ugandans.

7 Clients (7%) of 100 arrived refugees are LGBT from Uganda, Syria and Columbia.

JFCS-East Bay estimates that approximately 20-25% are resettled in Alameda County. Partners request that the agencies start to keep track of which county their clients are resettled to share in future.

We are at 87% of our arrival number. We only need 19 more refugees to make our goal of 150 for the fiscal year. For the top three new arrival groups, Afghans account for 69% of the caseload, followed by Iraqis (14%) and those from Burma (6%).
